



CHANGCHUN 2027 WINTER UNIVERSIADE

SNOWSPORT

The FISU Winter Universiade will take place in Changchun, China with the Opening Ceremony taking place on 15th January and Closing Ceremony on 25th January 2027, with all competition dates between. The event website can be found [here](#), providing more information on the event.

British Universities and Colleges Sport (BUCS) is sanctioning a GB Students delegation as National University Sports Federation (NUSF) to represent the United Kingdom of Great Britain and Northern Ireland.

Please read all the information below carefully, taking note of deadline and all actions required to self-nominate.

Nominations

All athletes who wish to be considered for selection must complete and submit their self-nomination online form and upload all relevant files on the [BUCS website](#) by 11:59pm Friday 11th September.

Any athlete who fails to complete the online registration may not be considered for selection.

To complete the self-nomination online form you will be required to upload the following documents:

- Accreditation photo (passport size, white background, neutral expression, no selfies)
- Passport (in a jpeg or pdf format with a **minimum of 6 months validity** after the expected return flight date)
- FISU Eligibility Certificate (this process will necessitate your university confirming your eligibility in writing on a template form and gaining your University stamp. The form is available for download on the online registration form – this will need to **be signed and stamped by a member of your university**).

Please note there may be additional documentation requirements for para-athletes. On completion of your online registration, Amy Garrett, the International Student Sport Coordinator will be in contact to liaise with you directly any additional documentation requirements.

Selections

Selections will take place by **COB Friday 25th September 2026**

Selected athletes will be notified their selection by email by BUCS w/c **28th September 2026**.

Once BUCS writes to confirm the selected Athletes, the process is open for any appeals. Please see the appeals process towards the end of this document for further information.

Once the appeals process has been completed and the final selection has been confirmed, you will have **24 hours** to confirm your acceptance to BUCS, return your completed **Team Member Agreement** and confirm your preferred payment option.

Upon receipt of your completed Team Member Agreement and confirmation of your acceptance, you will be issued an invoice to secure your place.

Post this, we will be in touch to book a phone call to discuss your travel plans.

There are 3 payment options available.

1. Payment of the full amount at the point of selection.
2. Payment of non-refundable deposit at the point of selection, 2nd payment of remaining balance by 1st December.
3. Payment of non-refundable deposit at the point of selection, the remaining balance paid in two monthly instalments on 1st November and 1st December.

Athletes submitting a nomination acknowledge this requirement and accept financial liability including in the case of withdrawal related to injury or illness.

***Shared coach** - To be discussed with each athlete/discipline. Any increase in coaching support will result in additional costs, which are shared between the athletes of that event. Please note: we are also limited by the number of accreditations available, depending on our final delegation size.

Additional Coaches - additional coach accreditation can be requested to BUCS, requests will be reviewed against total delegation size and the number of accreditations the OC grant us. Noting, all costs will be born by the Athletes for any additional coaches and related costs.



Travel information

The GB Students Snowsport delegation is anticipated to arrive at Changchun Longjia International Airport (CGQ), the official entry point, in line with the official arrival and departure dates for the relevant sporting disciplines.

Travel and competition dates are based on the FISU draft schedule (as of 1 June 2026), available [here](#). As FISU and the OC may continue to update the schedule, please check online for the latest version.

Based on the current schedule, GB Snowsports and BUCS have developed a draft travel plan to help determine the anticipated number of days at the event and estimate the associated costs for each event, as shown above. Costs are presented as a range to reflect the current uncertainty around travel dates, duration of stay and final delegation numbers.

As the competition schedule remains provisional, all costs are indicative estimates. We aim to confirm the final costs once the OC publishes the final schedule and our delegation numbers are confirmed following completion of all sport selections, expected by mid-to-late October.

These travel dates allow 48 hrs to land and settle at the event, aligning also to the FISU Technical regulations which state: *Athletes taking part in the Winter Universiade must arrive in the Universiade Village at least 48 hours before their first competition.*

Once your selection has been accepted, Amy Garrett, the International Student Sport Coordinator, will be in touch to discuss the competition schedule and your proposed travel plans, and to agree the most appropriate travel arrangements so SnowSport Athletes can book their own return flights and UK transfers. This will also help us finalise costs and total nights staying at the event.

Payment Plan – outlined in selection process above

Deposit

The deposit required is £400.

What's included in the costs

The costs above include event entry, accreditation, accommodation, food, in-country airport transfers and GB Students winter leisure kit (see provisional list below). They also include a contribution towards the central support team, including the Chef de Mission and a small volunteer support team (dependent on final athlete numbers), as well as physiotherapy and medical provision.

**Not included:**

Return flights and your travel / sport insurance is not included in the costs. In coordination with Amy Garrett, BUCS International Student Sport Coordinator, Athletes are to book and pay for their own return flights and UK transfers.

Coaches / Fee's

At FISU Winter Universiade the cost of the Team Manager or/and Team Coach will not be covered by GB Snowsports. This is reflected in the above amount and covers their travel, kit, accreditation and stay / food at the event.

Coaching fees shall be arranged directly with coaches, and any coaching fees will be settled between athlete and coach.

Non-BUCS Member Universities

Please note: Students from universities not included as part of the BUCS membership will be required to pay an additional £200 surcharge.

VISA Information / costs covered by Athlete

Please note that all VISA costs are to be covered by the athlete. Once we receive more information from the OC, we will share this with each athlete-student.

Dual Nationality

If you are dual nationality, please ensure you travel on and with your British Passport.

Anti-Doping

All athletes must complete the UKAD Complete Clean+ eLearning course and upload a copy of their course certificate upon nomination. The **Complete Clean+** eLearning can be accessed for free via the [UKAD Clean Sport Hub](#). Once registered, athletes can click onto the relevant eLearning and complete the modules at their convenience. **Complete Clean+** contains 11 modules which explore Anti-Doping topics including athletes' rights under the World Anti-Doping Code, UK Anti-Doping Rules, the Prohibited List, checking medications and supplements, the Testing Process and how to report concerns around doping in sport.



Eligibility Criteria

Further to any FISU regulations in place at the time, for an individual to be eligible to represent BUCS/GB Students in FISU competitions they shall:

INT 1.1.1 Be a British (United Kingdom) national.

INT 1.1.2 Be a registered student at an institution which is a recognised provider of Higher Education (HE).

AND

INT 1.1.3 be at least 18 and no older than 28 years of age on 31 December 2027 (i.e., born between 1 January 1999 and 31 December 2009). Para Alpine Skiing and Para Cross-Country Skiing athletes must be at least 18 on 31 December of the year of the event (i.e., born on or before 31 December 2009);

AND

INT 1.1.4 Be registered on a course which is at or above one of the following minimum levels:

- Level 4 on the Framework for higher education qualifications in England, Wales and Northern Ireland (FHEQ).
- Level 7 on the Scottish Credit and Qualifications Framework (SCQF).
- Level 4 on the Regulated Qualifications Framework for England and Northern Ireland (RQF).
- Level 4 on the Credit and Qualifications Framework for Wales (CQFW).

INT 1.1.4.1 An individual at an institution outside of the UK shall be registered on a course equivalent to those covered under INT 1.1.4.

AND

INT 1.1.5 Be undertaking a study programme equivalent to:

- Where the course is credit rated under CATS (Credit Accumulation and Transfer Scheme), at least 60 credits per year.
- Where the course is run using guided learning hours, a minimum of 225 hours per year.
- Where the course is a postgraduate course which is not credit rated, no less than 50% of the full-time student programme per year.

INT 1.1.5.1 A year will be taken as 12 months from the start date of their course.

INT 1.1.5.2 An individual at an institution outside of the UK shall be undertaking a study programme equivalent to the requirements of INT 1.1.5.

AND

INT 1.1.6 Be a player who is permitted by the International or National Governing Body of the sport concerned to participate in FISU competition alongside any other competition in that sport.



AND

INT 1.1.7 Meet the Sport Specific Eligibility Requirements as defined in the individual competition selection policy for that competition

INT 1.2 Special cases for participation Further to any FISU regulations in place at the time, the following individuals are classified as eligible to represent BUCS & GB Students in FISU competitions:

INT 1.2.1 Notwithstanding INT 1.1.5, an individual who is otherwise eligible under INT 1.1 on a sandwich/industrial placement as part of their course is eligible during this time.

INT 1.2.2 A former student of an eligible institution (as per INT 1.1.2) who has obtained an eligible qualification (as per INT 1.1.4) from said institution in the calendar year preceding the event. For this event Students graduating in 2026 will be eligible to compete in 2027, as former students who have obtained their qualification in the calendar year preceding the event.

INT 1.2.3 A student who would otherwise be eligible under INT 1.1. who has their studies suspended will not be eligible to compete until such a time as their studies recommence.

See also detailed eligibility information at the end of this document in **Appendix 1**.

Please note that any athlete who is currently suspended or expelled by FISU, WADA, International or National Federation is ineligible for selection.

Snow Sport - Sports Criteria

Alpine

GBS will consider athletes for Selection to the Winter FISU World University Games based upon the following criteria:

Men/Women	FIS points
Slalom	55.00
Giant Slalom	55.00
Super G	60.00

If more athletes are proposed than quota places are available, the Selection Panel has discretion to select the athletes most likely to achieve the best result at the Competition.

The Selection Panel will consider a range of factors when selecting athletes, but will include:

- athletes' FIS ranking in the eligible discipline during the current season; and
- results obtained in Competitions in the eligible discipline during the current season with greater emphasis on more recent results in order to select on current form. The panel will consider, amongst other things, where and in which season points were earned and any other relevant profiling
- athlete readiness to compete.

- In selecting to the Mixed Team Parallel the Selection Panel has discretion to select athletes on their ability to produce credible results in the event, over their ability to produce credible results in the individual Events. Final Team Selection is at the discretion of the GBS Alpine Coaches and GBS Performance Director.

The Selection Panel will consider a range of factors when selecting athletes, but will include (in no priority):

- an athlete's world ranking in the eligible discipline during the qualification period; and
- results obtained in Competitions during the current and preceding season with greater emphasis on more recent results in order to select on current form.

The Selection Panel will consider, amongst other things, where and in which season points were earned and any other relevant profiling

Cross Country

GBS will consider athletes for Selection to the Winter FISU World University Games based upon the following criteria:

If more athletes are proposed than quota places are available, the Selection Panel has discretion to select the athletes most likely to achieve the best result at the Competition.

The Selection Panel will consider a range of factors when selecting athletes, but will include:

- athletes' FIS ranking in the eligible discipline during the current season; and
- results obtained in Competitions in the eligible discipline during the current season;
- and athlete readiness to compete.

In extraordinary circumstances, the Selection Panel has absolute discretion to consider (and give additional weight to) any other factors they deem relevant in respect of their nomination decisions including (but not limited to) the likelihood of an athlete being podium competitive in future Olympic Games in accordance with the purpose of the Policy. Any such nominations must be made by a Discipline Head Coach, and must be supported with training and competition data, or technical profiling for consideration by the Selection Panel.

- results obtained in Competitions in the eligible discipline during the current season; and

GBS will consider athletes for Selection to the Winter FISU World University Games based upon the following criteria:

Athletes must maintain an average amplitude in excess of 2m throughout a top to bottom Halfpipe run with a minimum trick requirement of two different 900s.	Athletes must maintain an average amplitude in excess of 1m throughout a top to bottom Halfpipe run with a minimum trick requirement of two different 540s.

If more athletes are proposed than quota places are available, the Selection Panel has discretion to select the athletes most likely to achieve the best result at the Competition.

The Selection Panel will consider a range of factors when selecting athletes, but will include:

- athletes' FIS ranking in the eligible discipline during the current or preceding season;
- results obtained in Competitions in the eligible discipline during the current season; and
- athletes' Technical profile and readiness to compete.

In extraordinary circumstances, , the Selection Panel has absolute discretion to consider (and give additional weight to) any other factors they deem relevant in respect of their nomination decisions including (but not limited to) the likelihood of an athlete being podium competitive in future Olympic Games in accordance with the purpose of the Policy. Any such nominations must be made by a Discipline Head Coach, and must be supported with training and competition data, or technical profiling for consideration by the Selection Panel.

Snowboard Slopestyle & Big Air

GBS will consider athletes for Selection to the Winter FISU World University Games based upon the following criteria:

Men	Women
Athletes must be at a consistent trick performance level of two different direction 1080s with grabs executed on a large kicker.	Athletes must be at a consistent trick performance level of two different 540s with grabs executed on a large kicker.

If more athletes are proposed than quota places are available, the Selection Panel has discretion to select the athletes most likely to achieve the best result at the Competition.

- The Selection Panel will consider a range of factors when selecting athletes, but will include:
- athletes' FIS ranking in the eligible discipline during the current or preceding season;
- results obtained in Competitions in the eligible discipline during the current season; and
- athletes Technical Profile and readiness to compete, taking into consideration the competition format of the event. e.g. if the competition format requires a spin in both directions, this technical requirement will be considered by the Selection Panel when using technical profiling as a criteria for selection.

In extraordinary circumstances, the Selection Panel has absolute discretion to consider (and give additional weight to) any other factors they deem relevant in respect of their nomination decisions including (but not limited to) the likelihood of an athlete being podium competitive in future Olympic Games in accordance with the purpose of the Policy. Any such nominations must be made by a Discipline Head Coach, and must be supported with training and competition data, or technical profiling for consideration by the Selection Panel.

Snowboard Halfpipe

GBS will consider athletes for Selection to the Winter FISU World University Games based upon the following criteria:

- Athletes must have two results at Continental Cup level or high
- If more athletes are proposed than quota places are available, the Selection Panel has discretion to select the athletes most likely to achieve the best result at the Competition.
- The Selection Panel will consider a range of factors when selecting athletes, but will include:
- athletes' FIS ranking in the eligible discipline during the current season; and
- results obtained in Competitions in the eligible discipline during the current season; and
- athlete readiness to compete.

Alpine Snowboard

GBS will consider athletes for Selection to the Winter FISU World University Games based upon the following criteria:

- Athletes must have two results at Continental Cup level or higher; results not gained at Europa Cup competitions shall be subject to additional scrutiny by the Head Coach to assure the Panel of their quality.
- If more athletes are proposed than quota places are available, the Selection Panel has discretion to select the athletes most likely to achieve the best result at the Competition.
- The Selection Panel will consider a range of factors when selecting athletes, but will include:
- athletes' FIS ranking in the eligible discipline during the current season; and
- results obtained in Competitions in the eligible discipline during the current season; and
- athlete readiness to compete.

Selection Panel

The Selection Panel, which is responsible for the implementation of the Policy, will be chaired by an individual nominated by the GB Snowsport.

The Selection Panel will consist of the:

- Chair nominated by GBS
- GBS Performance Director/Head Coach
- Independent Legal Adviser (as nominated by the GBS Nominations Committee);
- Chair of the Relevant Discipline Committee (or nominated representative); and
- Relevant Coach for the Discipline
- BUCS; either Head of International Student Sport, or International Student Sport Coordinator will represent at the selection panel, as an observer and non-voting member.

Appeals

Any Appeal against a decision of the Selection Panel must follow strict procedures. The following procedure is applicable to all disciplines in respect of Selections.

Any Appeal against Selection for an Olympic Games must follow the Appeal Process laid down in the Olympic Games Selection Policy.

Grounds of Appeal

An athlete, or their Authorized Representative, ("the Appellant"), may make an Appeal against a Selection decision only on one or more of the following grounds:

- there has been a failure to apply the Criteria contained in the relevant Schedule correctly;
- the Selection Panel has failed to follow its procedures properly; and/or
- the Selection Panel's discretion has not been exercised in a reasonable manner and that such discretion was exercised in such a way as to be prejudicial to the Appellant.

The Process

In the first instance an Appeal is made to the Selection Panel, who will consider the Appeal and respond, either:

- a) agreeing with the Appellant and changing the original decision; or
- b) rejecting the Appellant's Appeal and explaining its reasons for the decision.

If an Appellant is not satisfied with the outcome of the Selection Panel's further deliberations, then the Appellant may make a further Appeal ("the Second Appeal Notice") to a different panel, the Appeal Panel ("the Appeal Panel"), based on the same grounds of Appeal and Appeal Notice.

Outcomes available to the Appeal Panel are:

- to confirm the Selection decision under Appeal and reject the Appeal; or
- to refer the Selection decision under Appeal back to the Selection Panel, identifying errors they have made in their deliberations or process, (as per the grounds outlined in clause 7.3), and requesting a new decision is made, or the original decision is confirmed correcting any errors made by the Selection Panel within a timeframe which allows their conclusions to be implemented.

How to Appeal

- An Appeal Process is commenced by the Appellant, addressing an email to the Chair of the Selection Panel appealing against a decision made by the Selection Panel that resulted in the athlete not being selected. ("Notice of Appeal"). The email should be sent to appeals@gbsnowsport.com. The email must be sent within 2 business days of the notification of Selection/non-Selection.

The Notice of Appeal must clearly set out the details of the decision which is being appealed and include full details of the Appellant's ground(s) of Appeal. The Notice of Appeal should attach any documents or written evidence relevant to the grounds of Appeal and which are relied upon by the Appellant.

All Appeals must be accompanied by a bank transfer of £250 which will be refunded should the Appeal be upheld under Clause 7.6.2 above.



Following the Appellant being informed of the outcome of the Selection Panel's further deliberations under Clause 7.4, the Appellant can raise a Second Appeal Notice if they do not agree with the outcome of the Selection Panels further deliberations. The Second Appeal Notice is reviewed by an independent Appeal Panel. The Second Appeal Notice must be made via email to appeals@gbsnowsport.com and be received by GBS within 2 business days (Squad Selection), or 1 business day (Competition Selection) of the Appellant being informed of the Selection Panel's decision under Clause 6.4. For EYOF 2025, given tight deadlines set by the IOC, the Second Appeal Notice must be received by GBS within 2 hours of the Appellant being informed of the Selection Panel's decision under Clause 7.4.

In the event of any Appeal, minutes of the Selection Panel's Selection decisions or of any Appeal hearing will be made available to the Appellant upon request and will be provided within one business day of such request. In some cases, it may be necessary to redact elements of the relevant minutes.

The Appeal Panel

GBS will nominate an Appeal Panel of at least 3 members, none of whom sat on the Selection Panel, and none of whom are conflicted. One of the members of the Appeal Panel will have a legal background. The members will select a Chair of the Appeal Panel.

The Appeal Panel must receive the Second Appeal Notice within the time frames stated in Clause 7.10. The only fee required is when the Appellant first makes an Appeal to the Selection Panel. A second fee is not required if the Appeal reaches the Appeal Panel.

The Chair of the Appeal Panel will convene a meeting to take place within 5 business days of the Second Appeal Notice, (Squad Selection) or, if urgent for reasons of a specific event, then to take place within a time frame which allows their conclusions to be implemented.

The Appeal Panel will investigate the grounds of Appeal set out in the Second Appeal Notice and establish, to their reasonable satisfaction, which of the outcomes set out in Clause 6.6 is appropriate. The Chair of the Appeal Panel will notify the Selection Panel and the Appellant of their decision immediately after the meeting.

The decision of the Appeal Panel, and if required, subsequent review by the Selection Panel, following the Second Appeal Notice is final. No further Appeal of the same initial grounds of appeal will be considered.

INT 1.1.1 Be a British (United Kingdom) national.

INT 1.1.2 Be a registered student at an institution which is a recognised provider of Higher Education (HE).

AND

INT 1.1.3 be at least 18 and no older than 28 years of age on 31 December 2027 (i.e., born between 1 January 1999 and 31 December 2009). Para Alpine Skiing and Para Cross-Country Skiing athletes must be at least 18 on 31 December of the year of the event (i.e., born on or before 31 December 2009);

INT 1.1.4 Be registered on a course which is at or above one of the following minimum levels:

- Level 4 on the Framework for higher education qualifications in England, Wales and Northern Ireland (FHEQ).
- Level 7 on the Scottish Credit and Qualifications Framework (SCQF).
- Level 4 on the Regulated Qualifications Framework for England and Northern Ireland (RQF).
- Level 4 on the Credit and Qualifications Framework for Wales (CQFW).

INT 1.1.4.1 An individual at an institution outside of the UK shall be registered on a course equivalent to those covered under INT 1.1.4.

AND

INT 1.1.5 Be undertaking a study programme equivalent to:

- Where the course is credit rated under CATS (Credit Accumulation and Transfer Scheme), at least 60 credits per year.
- Where the course is run using guided learning hours, a minimum of 225 hours per year.
- Where the course is a postgraduate course which is not credit rated, no less than 50% of the full-time student programme per year.

INT 1.1.5.1 A year will be taken as 12 months from the start date of their course.

INT 1.1.5.2 An individual at an institution outside of the UK shall be undertaking a study programme equivalent to the requirements of INT 1.1.5.

AND

INT 1.2 Special cases for participation Further to any FISU regulations in place at the time, the following individuals are classified as eligible to represent BUCS/GB Students in FISU competitions:

INT 1.2.1 Notwithstanding INT 1.1.5, an individual who is otherwise eligible under INT 1.1 on a sandwich/industrial placement as part of their course is eligible during this time.

INT 1.2.2 A former student of an eligible institution (as per INT 1.1.2) who has obtained an eligible qualification (as per INT 1.1.4) from said institution in the calendar year preceding the event.

INT 1.2.3 A student who would otherwise be eligible under INT 1.1. who has their studies suspended will not be eligible to compete until such a time as their studies recommence.

INT 1.3 Gender eligibility For all FISU competitions, the gender eligibility criteria will be as communicated by FISU.

INT 1.4 Anti-Doping All participants in FISU competitions are subject to the Anti-Doping rules of UK Anti-Doping (UKAD), the World Anti-Doping Agency (WADA), FISU, and the specific sport's International and/or National Governing Body. As such:

INT 1.4.1 All participants are subject to testing.

INT 1.4.2 Any individual receiving treatment involving a Prohibited Substance or Method, as described on the World Anti-Doping Agency's Prohibited List, should apply for a standard Therapeutic Use Exemption.

INT 1.4.3 Any individual who is serving a suspension as a result of an Anti-Doping rule violation will not be eligible to participate in any FISU competitions.

INT 1.4.4 All delegates will be required to complete the UKAD Introduction to Clean Sport qualification prior to attending the any GB representative event.
