LOCAL RULES and TERMS OF COMPETITION

The following Local Rules and Terms of Competition, together with any additions or amendments published by BUCS/SSS at the golf course, will apply to all Tour events run by BUCS and/or SSS.

For the full text of any Local Rule referenced below, please refer to the Official Guide to the Rules of Golf effective January 2019 and the Clarifications updated quarterly by The R&A, available at www.randa.org.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty (loss of hole in match play or two penalty strokes in stroke play).

1. Out of Bounds (Rule 18.2)

- 1a) Beyond any wall, fence, hedge or line of white stakes defining the boundary of the course.
- 1b) On or beyond any white line defining the boundary of the course.
- 1c) Where a boundary is defined by a white line and, furthermore, white stakes with black tops have been placed for visibility, these stakes are movable obstructions.

2. Penalty Areas (Rule 17)

- 2a) When both stakes and lines are used, the line defines the margin of the penalty area.
- 2b) When a penalty area adjoins a boundary, the penalty area edge extends to and coincides with the boundary.
- 2c) When a player's ball is found in or it is known or virtually certain to have come to rest in any penalty area where the ball last crossed the edge of the penalty area at a point that coincides with the boundary of the course, opposite side relief is available under Model Local Rule B-2.1.

Dropping Zones for Penalty Areas

Where a dropping zone is marked for a penalty area, it is an additional option for relief under penalty of one stroke. The dropping zone is a relief area. A ball must be dropped in and come to rest in the relief area.

3. Abnormal Course Conditions (including Immovable Obstructions) (Rule 16)

3a) Ground Under Repair

- i. Any area bounded by a white line.
- ii. Any area of damaged ground that is considered by a referee to be abnormal.
- iii. French drains (stone-filled drainage ditches).
- iv. Seams of cut turf; Model Local Rule F-7 is in effect but interference does not exist if the seam only interferes with the player's stance.
- v. Yardage painted lines or dots on the putting green or in a part of the general area cut to fairway height or less are to be treated as ground under repair from which relief is available under Rule 16.1. Interference does not exist if yardage painted lines or dots only interfere with the player's stance.

3b) Immovable Obstructions

- i. White lined areas and the immovable obstruction they tie into are treated as a single abnormal course condition.
- ii. All artificially surfaced roads and paths on the course, including those covered with woodchip or mulch. Individual pieces of woodchip are loose impediments.

3c) Embedded Ball

Rule 16.3 is modified in this way: No free relief is allowed for a ball embedded in the stacked turf face or soil face above a bunker.

4. Immovable Obstructions Close to Putting Greens

Model Local Rule F-5 is in effect: In addition to the types of interference described in Rule 16.1a, when a ball lies in the general area, interference also exists if an immovable obstruction is, on the player's line of play, is within two club-lengths of the putting green, and is within two club-lengths of the ball. The player may take relief under Rule 16.1b.

Exception: There is no relief under this Local Rule if the player chooses a line of play that is clearly unreasonable.

5. Ball Played From Outside Relief Area When Taking Back-On-The-Line Relief

Model Local Rule E-12 is in effect.

6. Integral Objects

The following are integral objects from which free relief is not allowed:

6a) Artificial bunker faces.

6b) Bunker liners in their intended position.

7. Temporary Immovable Obstructions

Model Local Rule F-23, with any additions or amendments in the additional Local Rules published by England or Scottish Golf, is in effect. TIOs include on-course scoreboards.

8. Replacement of Club that is Broken or Significantly Damaged

Model Local Rule G-9 is in effect.

9. Protection of Young Trees

Young trees identified by wrapping, stakes or otherwise protected are no play zones:

9a) If a player's ball lies anywhere on the course other than in a penalty area and it lies on or touches such a tree or such a tree interferes with the player's stance or area of intended swing, the player must take relief under Rule 16.1f.

9b) If a ball lies in a penalty area, and interference to the player's stance or area of intended swing exists from such a tree, the player must take relief either with penalty under Rule 17.1e or with free relief under Rule 17.1e(2).

10. Clubs and Balls

10a) List of Conforming Driver Heads: Model Local Rule G-1 is in effect.
Penalty for making a stroke with a club in breach of Local Rule: Disqualification.

10b) Groove and Punch Mark Specifications: Model Local Rule G-2 is in effect.
Penalty for making a stroke with a club in breach of Local Rule: Disqualification.

10c) List of Conforming Golf Balls: Model Local Rule G-3 is in effect.

11. Pace of Play (Rule 5.6)

Player Responsibilities:

- Be ready to play and play Ready Golf where possible
- Play a provisional ball if you think your ball may be lost or out of bounds
- If your group is Out of Position, it is your responsibility to get back into position as soon as possible

Every BUCS Tour event and BUCS Championship Event has a Pace of Play Policy that will be strictly enforced. Please ensure you obtain a copy of the Pace of Play Policy and read it carefully before playing.

12. Suspension of Play (Rule 5.7)

The following signals will be used to suspend and resume play:
Immediate stop for imminent danger - one prolonged note of a siren
Stop for a non-dangerous situation - three consecutive notes of a siren
Resumption of play-two consecutive notes of a siren

Note: When play is stopped for imminent danger, all practice areas will be immediately closed.

13. Practice (Rule 5.2)

13a) In stroke play, Rule 5.2b is modified in this way: A player must not practise on the competition course before or between rounds.

13b) In match play, Rule 5.2a is modified in this way: A player must not practise on the competition course before or between rounds.

Exception: All recognised practice areas within the bounds of the course may be used by players for practice on any day of the competition.

14 Transportation

During a round, a player or caddie must not ride on any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation. The player gets the general penalty for each hole during which there is a breach. A breach between two holes applies to the next hole.

15 Use of Equipment (Rule 4.3)

The capturing, distribution or viewing of video or images showing play of the player or players during competition that helps the player in choosing a club, making a stroke, or deciding how to play during the round is prohibited.

16 Eligibility

Players must meet the eligibility provisions established in the relevant Terms of Competition for the specific Championship or Match.

17 Anti-Doping

Players are required to comply with and be bound by any Anti-Doping Policy that is established for the Championship or Match in which they are competing, as detailed in the relevant Terms of Competition, as advised by prior notice or at the golf course.

18 Returning of Score Card

A player's scorecard is officially returned to the Committee when the player has left the recording office/area with both feet.

19 Deciding Ties

When possible the winner of all BUCS Tour events will be decided by a sudden death playoff (holes to be determined by the Tournament Director before the playoff commences). If the Tournament Director deems that a playoff is not possible players will be notified ahead of the tournament commencing and will be decided on countback (last 18 holes, last 9, last 6, last 3, last 1).

20 Results of Match or Championship - Competition Closed

20a) Match Play

The result of a match is officially announced when it has been recorded in the Championship Office.

20b) Stroke Play

When the Championship trophy is presented to the winner, the results of the competition are officially announced, and the competition is closed.
