

BUCS GENERAL REGULATIONS - SIGNIFICANT CHANGES FOR 2023-24 (VERSION 1)

PUBLISHED | 18 OCTOBER 2023

SUMMARY

This document highlights some of the changes to BUCS' General Regulations for the 2023-24 season that institutions/Playing Entities should be aware of.

It is not a record of all changes, as it does not contain details of any minor editorial changes, such as wording changes which do not affect the purpose of the regulations, or changes to numbering where regulations have been reordered.

Updated versions of this document will be published should there be further updates to regulations following its initial publication.

Following queries received by the BUCS Executive regarding this regulation, there is a need for more clarity to be provided. The BUCS Executive's current application/interpretation of REG 4.2.1 is that each institution/Playing Entity can have an unrestricted number of sabbatical officers compete for them each season, regardless of their role - for example VP Sports or Education and Welfare Officer - and regardless of whether the institution/Playing Entity has more than one such body and if the one they are an officer for is responsible for the delivery of sport and/or BUCS activity. For example, if there is a separate Athletic Union and Students' Union, but both have sabbatical officers, then all these officers would be eligible. This allowance for sabbatical officers to compete if they have "paid the appropriatesubscription" has been in place since at least the 1997-98 (then BUSA) season. Prior to the 2018-19 season the wording was: "A sabbatical officer of either a Students' Union or an Athletic Union who has paid the appropriate Union or Athletic Union subscription.". In an explanation of terminology section of the regulations, there was no mention of Students' Unions, but references to Athletic Union were said to be referring to: "The body within a University or Institute of Higher Education recognised by BUSA being responsible for the organisation of student sport within that institution.". 	option for Athletic Union officers. The intention of this update to the wording is to provide clarity over eligibility, not to change who is eligible. A review of whether all such individuals should remain eligible, will be part of a wider review of REG 4 which the BUCS Executive intend to form a working group to support during the 2023-24 season.

REG 4.3 Transgender athletes BUCS supports equal opportunities in sport for all, to include transgender athletes on the basis of the gender with which they identify. BUCS promotes a zero tolerance approach to transphobia and any person or institution found to be in contravention of this regulation will face disciplinary action under REG 5. The participation of a transgender athlete in competitive sport must not be restricted unless it is proportionate to the aim of securing safe and/or fair competition.

REG 4.3.1 Where the International or National governing body has a policy on transgender participation in sport this shall be followed, as per the Sport Specific Regulations. Where the International or National Governing Body have no such policy REG 4.3.2 through to REG 4.3.3 shall apply. Where the relevant International or National Governing Body have a policy, but it has not been reviewed within a 3 year period, the BUCS regulation may apply.

REG 4.3.2 Transgender athletes not taking hormone treatment Any transgender athlete who is not taking hormone treatment related to gender transition may participate in BUCS competitions in accordance with their gender as assigned at birth. **REG 4.3.2.1** A trans male (female to male) who is not taking testosterone relating to gender transition may participate in male or female competition. However they may not compete in both categories within 1 BUCS season. For example, if a trans male chooses to compete in male competition, they may not compete in any female competition in any sport in the same season. REG 4.3.2.2 A trans female (male to female) who is not taking hormone treatment related to gender transition may not compete in female competition, but may participate in a male competition. **REG 4.3.3 Transgender athletes undergoing**

REG 4.3 Transgender athletes The participation of a transgender athlete in competitive sport must not be restricted unless it is proportionate to the aim of securing safe and/or fair competition. The following sub-regulations outline the processes for determining eligibility for each sport.

REG 4.3.1 Where the National Governing body for the sport where the activity is taking place has a policy on transgender participation in sport this shall be followed. If the National Governing Body does not have a policy on transgender participation the International Federation policy on transgender participation shall be followed. Where both the National Governing Body and International Federation have no such policy, REG 4.3.2 through to REG 4.3.3 shall apply.

REG 4.3.2 Transgender athletes not taking hormone treatment Any transgender athlete who is not taking hormone treatment related to gender transition may participate in BUCS competitions in accordance with their gender as assigned at birth.

REG 4.3.2.1 A trans male (female to male) who is not taking testosterone relating to gender transition may participate in male or female competition.

However they may not compete in both categories within 1 BUCS season. For example, if a trans male chooses to compete in male competition, they may not compete in any female competition in any sport in the same season.

REG 4.3.2.2 A trans female (male to female) who is not taking hormone treatment related to gender transition may not compete in female competition, but may participate in a male competition.

REG 4.3.3 Transgender athletes undergoing hormone treatment for gender transition The following will determine in which category a transgender athlete is eligible to compete.

REG 4.3.3.1 A trans male (FTM) who has received medical treatment with testosterone related to

gender transition may compete in male competition

It is important for BUCS programmes to continue to provide inclusive opportunities for all students to compete and to reflect the wider development and implementation of the sport in line with National Governing Body and International Federation policy advances. These changes to REG 4.3 remove wording which is covered in the BUCS Transgender Policy and provide clarity on the sequential process that is currently followed (and reference within the BUCS Transgender Policy) when determining which policy documentation to follow to determine eligibility of athletes.

The updated regulation wording also clarifies that reference to a National Governing Body policy relates to where the activity is taking place, as not every sport has a British or UK governing body, with many having separate NGBs for each nation.

These changes do not alter the eligibility of individuals ahead of the upcoming season as BUCS does not want to make changes of such a nature without significant consultation, to allow for informed documentation. BUCS asks that the membership support the BUCS Executive over the next season while we work to better understand the demographics of the athletes taking part in our competitions and events and consult across the stakeholder network to inform changes ahead of the 2024-25 season.

REG 9.2 Fixture dates

REG 9.2.1 League matches All league matches must take place on the fixture date as set by BUCS, unless agreed by both institutions/Playing Entities to move the fixture to an alternative date in writing (once agreed, BUCS Play must be updated immediately) or by way of an accepted fixture change request on BUCS Play.

REG 9.2.1.1 Teams from the same institution/Playing Entity in the same league

Where two teams from the same institution/Playing Entity are in the same league, BUCS will not schedule a fixture between the two teams for the last week of competition. Institutions/Playing Entities are also forbidden to reschedule fixtures between their own teams to be the last league fixture for either of their teams. Should an institution/Playing Entity be found to have done so, the result will be voided, and no points will be awarded to either team.

REG 9.2.1.2 All fixtures must take place by the relevant league deadline date as identified in Appendix 2 ('BUCS Leagues and Knockouts – Dates and Deadlines'). Please note REG 13 for result entry and amendment processes and deadlines.

REG 9.2.1.3 Matches not completed by the date stated in Appendix 2 ('BUCS Leagues and Knockouts – Dates and Deadlines') shall be declared void with no points being awarded to either side, unless a walkover is claimed or conceded by the relevant deadline.

REG 9.2.1.4 All Premier Tier league fixtures must be fulfilled. Any team failing to complete their Premier Tier programme may be subject to disciplinary action.

REG 9.2 Fixture dates

REG 9.2.1 League matches All league matches must take place on the fixture date as set by BUCS, unless agreed by both institutions/Playing Entities to move the fixture to an alternative date in writing (once agreed, BUCS Play must be updated immediately) or by way of an accepted fixture change request on BUCS Play.

REG 9.2.1.1 Where two or more teams from the same institution/Playing Entity are in the same league, BUCS will not schedule any fixtures between any of these teams to be their last league fixture. Institutions/Playing Entities must not reschedule fixtures for any of their teams that would result in the last scheduled league fixture for one of them being against another of their teams. Should an institution/Playing Entity be found to have done so, and it is no longer possible for the fixture to be rescheduled to not be the last scheduled league fixture for either team, then the fixture shall be declared void with no points awarded to either side.

REG 9.2.1.2 Institutions/Playing Entities are forbidden to reschedule fixtures to after the relevant league deadline date as identified in Appendix 2 ('BUCS Leagues and Knockouts – Dates and Deadlines'). Please note REG 13 for result entry and amendment processes and deadlines.

REG 9.2.1.3 Fixtures not completed by the relevant league deadline date as identified in Appendix 2 ('BUCS Leagues and Knockouts – Dates and Deadlines') shall be declared void with no points being awarded to either side, unless a walkover is claimed or conceded by the relevant deadline.

REG 9.2.1.4 All Premier Tier league fixtures must be fulfilled. Any team failing to complete their Premier Tier programme may be subject to disciplinary action.

REG 9.2.1.1 updated to provide clarity that teams can end up being scheduled to play each other last by their institution moving other fixtures, rather than that specific fixture, as well as that if identified early enough - before all other fixtures have passed/been completed - then it will still be possible for the match to be rescheduled.

Wording of REG 9.2.1.2 and REG 9.2.1.3 updated to better work together as there may be reasons that matches cannot take place.

If the scoreline at this time is a draw, then a result cannot be taken, unless alternative provision is made under the sport specific regulations, and the fixture should be rearranged in accordance with REG 14.3/REG 14.4/REG 14.5.

REG 9.3.4.6 If a knockout competition match is abandoned by the match official(s) before the completion of at least 75% of normal time as per REG 9.3.4.1 or any agreement under REG 9.3.4.2, then a result cannot be taken, unless alternative provision is made under the sport specific regulations, and the fixture should be rearranged in accordance with REG 14.3/REG 14.4/REG 14.5. **REG 9.3.4.7 Late arrivals** Where a team arrives late to a fixture every effort should be made for the fixture to be played in accordance with REG 9.3.4.1. REG 9.6 Double headers BUCS will not recognise any matches played as double headers (one match cannot produce the result for two league fixtures or a league and knockout competition fixture), with the exception of REG 9.6.1.

REG 9.6

REG 9.6.1 Teams in Tier 1 and below may request for a double header to be recognised in exceptional circumstances. Such a request must be submitted and approved by the BUCS Executive in advance of the fixture. Exceptional circumstances may include (but is not exclusive to) bad weather or facility availability due to unusual circumstances. Double headers between teams from the same institution/Playing Entity will not be permitted. The last league fixture for either team may not be played as a double header.

REG 9.6 One match cannot be used to produce the result for two league fixtures or a league and knockout competition fixture. For example, where two teams are scheduled to play each other home and away in a league, they cannot agree to only play once but with the result of this match being recognised for both scheduled matches.

From the 2005-06 (then BUSA) season until the end of the 2015-16 season, so called 'Double Headers' were not permitted. This was changed for the 2016-17 season, with the ability for teams in Tier 1 and below to make a request for these to be recognised - if approved by the BUCS Executive.

Since 2016-17, the most requests in a season has been 13. In recent seasons, more requests have been rejected than accepted. Some of these rejections have been because the request was for the last league fixture for one (or both) of the teams, others because they were for Premier Tier fixtures. However, others have been rejected based on the BUCS Executive's judgement as to whether there are 'exceptional circumstances'.

The guidance in the regulation as to what might be considered 'exceptional circumstances' doesn't seem clear or to fit with other regulations, given that bad weather and unforeseeable facility issues for a single fixture are covered under REG 14 as a reason for a postponement, so institutions would need to be demonstrating a longerterm weather or facility issue and explaining how they are not able to find other options that would be required otherwise by teams not able to request a double header because their remaining fixtures don't enable this. As a general point, very few 'double header' requests before January are approved given that there is a lot of the season still to use for a potential rearrangement.

The 'double header' option is only an option for those teams whose fixture schedule and

			chance situations enable. Whilst it gives the data that more fixtures have been 'completed' they haven't, so this regulation is not enabling more sport to happen, just more results to be recorded. The BUCS Executive have at times received complaints from teams in a league where others have been granted a 'double header' in order to "complete" their fixture schedule, when they are having fixture challenges which can't be addressed using this, seeing it as an unfair option. REG 10.6.1.1 Where the away institution/Playing Entity chooses not to host and agreement cannot be reached between the institutions/Playing Entities for rescheduling, the match shall be replayed at a venue and on a date determined by the BUCS Executive.

REG 10.6.2 Any institution/Playing Entity failing to notify the opposition of the failure to obtain the appropriate officials at least 48 hours (outside of weekends and bank holidays) before the fixture start time will forfeit the match and concede a walkover.

REG 10.6.3 Non-provision of officials due to being let down by an appointed/booked official within 48 hours of the fixture start time

REG 10.6.3.1 If the away team has arrived at the venue and the home team is let down by an appointed/booked official and can prove in writing that the official was appointed/booked, the original home team will be obliged to travel to a rescheduled match.

REG 10.6.3.2 If the away team has not yet travelled, and the home side notifies them that they have been let down by an appointed/booked official within 48 hours of the fixture start time (providing written evidence as per REG 10.6.3.1) the match shall be rescheduled to be played at the original home team venue.

REG 10.6.1.1 Where the away institution/Playing Entity chooses not to host and agreement cannot be reached between the institutions/Playing Entities for rescheduling, the match shall be replayed at a venue and on a date determined by the BUCS Executive.

REG 10.6.2 Any institution/Playing Entity failing to notify the opposition of the failure to obtain the appropriate officials at least 48 hours (outside of weekends and bank holidays) before the fixture start time will forfeit the match and concede a walkover.

REG 10.6.3 Non-provision of officials due to being let down by an appointed/booked official within 48 hours of the fixture start time

REG 10.6.3.1 If the away team has arrived at the venue and the home team is let down by an appointed/booked official and can prove in writing that the official was appointed/booked, the original home team will be obliged to travel to a rescheduled match.

REG 10.6.3.2 If the away team has not yet travelled, and the home side notifies them that they have been let down by an appointed/booked official within 48 hours of the fixture start time (providing written evidence as per REG 10.6.3.1) the match shall be rescheduled to be played at the original home team venue.



REG 11.1.3

REG 11.1.3 Where a Playing Entity has more than one team in a Championships (for example Men's Football), teams must be selected as if all teams are playing on a given day, at the same time, and in a match of equal importance. It would be expected that the first team would always be the strongest team available to represent that Playing Entity, with consideration to establishment of 'normality'. For example, if the first team does not have a match but the second team do, players who would normally* represent the first team are NOT eligible to play for the second team. *Normally is defined by an individual establishing 'normality' by being listed on the team sheets for a majority (more than 50%) of a particular team's total league fixtures. In the rare case that an individual has been listed on the team sheets for multiple higher ranked teams, then the totals of these will be combined and counted against the lowest of these teams' total league fixtures to identify if they are eligible to represent any lower ranked team. 'Normality'/majority is established through league fixtures only, however this regulation still applies to knockout competition fixtures unless specifically stated otherwise. **REG 11.1.3.1** Where a Playing Entity has more than one fixture scheduled across its teams in a Championships on a given day, priority must be given to the highest ranked team and then in descending order through their teams should the Playing Entity be unable to fulfil all scheduled fixtures. Matches played in contravention of this regulation will be awarded to the opposition, or in certain circumstances, be voided. For example, an institution/Playing Entity may NOT concede a walkover at second team level, while continuing to field a lower ranked team on the same day. **REG 11.1.3.1.1** For possible exceptions to REG 11.1.3.1 due to 'Ring Fencing' of teams, refer to

REG 11.1.3.1.1 For possible exceptions to REG

REG 11.1.3.1.1 For possible exceptions to REG 11.1.3.1 due to 'Ring Fencing' of teams, refer to REG 11.1.8.

Wording of REG 11.1.3 has been updated to try and help provide more clarity.

The new REG 11.1.3.2 has been formulated following a discussion at the July 2023 meeting of National Competitions Group.

A specific penalty is needed for a breach of REG 11.1.3 as:

- 1. Currently the match appeals route being the only way in which a team might face a sanction puts a lot of work on the non-offending team: They must first suspect/identify a breach before the appeal deadline passes, then investigate this to build a case/raise with the opposition. On the other hand, the offending institution only need respond if an appeal is made.
- 2. The outcome of a fixture involving a breach could negatively affect other teams. Without this change, such teams are unable to do anything about it directly or have a process through which to require BUCS to.

Note: Does not apply to Badminton (Premier) as has own regulation on team selection, Squash, Table Tennis or Tennis as their ranking list regulations say that they supersede REG 11.1.3.

REG 11.1.7.



REG 11.1.3.1.2 Involuntary walkovers may be granted if applied for in accordance with walkover regulations in REG 13 meaning that REG 11.1.3.1 would be suspended in some instances, for example on health and safety grounds. Application to suspend REG 11.1.3.1 must be made to the BUCS Executive in advance of affected fixtures.

REG 11.1.3.1.2 Involuntary walkovers may be granted if applied for in accordance with walkover regulations in REG 13 meaning that REG 11.1.3.1 would be suspended in some instances, for example on health and safety grounds. Application to suspend REG 11.1.3.1 must be made to the BUCS Executive in advance of affected fixtures.

REG 11.1.3.2 Where an institution/Playing Entity is found to have fielded (including as an unused substitute) an individual for a team below one which they have established 'normality' for:

In the case of a league match: If a breach of REG
 11.1.3 has been identified before the relevant league deadline date as identified in Appendix 2 ('BUCS Leagues and Knockouts – Dates and Deadlines') for the fixture for which there was a breach, the fixture shall be conceded as a walkover win to the opposition.

- In the case of a knockout competition match: If a breach of REG 11.1.3 has been identified before the following round, the fixture shall be conceded as a walkover win to the opposition. If, due to the proximity to the following round of the breach being identified, the team awarded the walkover win is not able to fulfil the following round fixture, this shall be recorded as an involuntary walkover win to the opposition, unless both teams agree to reschedule the fixture.

- NOTE: An institution/Playing Entity wishing to report a breach of REG 11.1.3 to the BUCS Executive should do so via email to discipline@bucs.org.uk and will be expected to ensure that there is validity to any claims before they make their report. Reports deemed to be frivolous or not containing adequate information may result in disciplinary action against the institution/Playing Entity.

compliance, with specific correlating sanctions for breaches identified through these checks as follows: REG 11.2.9.1 Squad Size Checks On the dates listed in Appendix 18 ('BUCS Squad Size Check Dates'), the BUCS Executive will run an export from BUCS Play to assess the current numbers of participants registered to each team's squad. If the number of participants in a team's squad is less than the minimum number of participants required to start the fixture as per the Sport Specific Regulations, then the team will receive a one-point deduction in their league competition. **REG 11.2.9.2 Spot Checks** The BUCS Executive will undertake spot checks on individual teams' team sheets throughout the season (after the dates of the squad size checks - SEE REG 11.2.9.1). A team will not be spot checked after their league's results submission deadline has passed. If any breaches are found during spot checks, then the following sanctions will be applied to the team: - 1-2 missing/incomplete team sheet(s) - written warning from BUCS. - 3 missing/incomplete team sheets – a one-point deduction in their league competition. - 4+ missing/incomplete team sheets - a three-point deduction in their league competition. Any missing/incomplete knockout competition team sheets will not count towards the above sanctions, but teams not correctly completing team sheets for knockout competition matches could still face consequences such as not being able to appeal or losing appeals because of this. REG 12.1

REG 12.1.1 If a team travels to, begins or continues a fixture with knowledge of conditions that amount to a breach of regulations but fails to complete a Playing Under Protest form they are deemed to have accepted the conditions of play and can therefore not later 'play under protest' regarding them, nor submit a match appeal (REG 15) based on those grounds.

REG 12.1 If a team feels, upon arrival or during a fixture, that the conditions do not adhere to those outlined in the BUCS rules and regulations, they should complete a 'BUCS Playing Under Protest Form' (Appendix 8) as soon as the grievance is noted. All teams are advised to carry with them at least two hard copies of the form so that they are adequately prepared for any such scenario. If a team does not have a BUCS Playing Under Protest Form with them, any equivalent paperwork used/produced must meet the requirements of REG 12.3.

REG 12.1.1 If a team travels to a fixture with prior knowledge of conditions that amount to a breach of regulations, they are deemed to have accepted these conditions of play and can therefore not later 'play under protest' regarding them, nor submit a match appeal (REG 15) based on those grounds.

REG 12.1.2 If a team begins or continues a fixture with knowledge of conditions that amount to a breach of regulations but fails to complete a Playing Under Protest Form when the grievance was noted, they are deemed to have accepted the conditions of play and can therefore not later 'play under protest' regarding them, nor submit a match appeal (REG 15) based on those grounds.

Wording updated to clarify that if a team travels, they cannot play under protest about something they have been made aware of prior to travelling.
